### NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

**In-person requests:** *A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).*

**Written requests:** *Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.*

**Website alternative:** *Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.*

**Permissible charges:** *Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.*

**Penalties:** *An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:*

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

**Private foundation exempt:** *The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.*



On a national level, the ministry seeks to serve and promote prayer for Christians and non-Christians working in media who significantly impact our culture, and share the gospel with those who respond. This is done through mobilizing people to pray through the Media Leader Prayer Calendar (which identifies the top 365 media leaders and top 365 cultural influencers), the daily Media Minute, and participation in the nationwide Oscar Sunday movement. In following the ministry's objective of contacting the top 1,000 media leaders, Mastermedia field staff set up appointments during the year

4b (Code: ) (Expenses \$ 341,612. including grants of \$ 100. ) (Revenue \$ ) East Coast Ministry (New York City area) The East Coast team undertakes ongoing one-on-one evangelism, mentoring, and spiritual conversations through outreach events to media professionals working in the Tri-State area. In 2016, there were numerous ongoing Bible studies, including an online study, as well as regular ongoing gatherings for media professionals. In addition, executive-level women's brunches/luncheons and Christmas and Easter events for non-believers and Christians working in media were held, as well as Media Forums for university students and seasoned Christian media executives. To augment the East Coast team's activities, twice a year, the West Coast leadership team travels to join the East Coast team for vital face-to-face outreach with top media

4c (Code: ) (Expenses \$ 262,714. including grants of \$ 250. ) (Revenue \$ ) West Coast Ministry (Greater Hollywood area) The West Coast team provides counsel and prayer support, and discipleship through small groups for men and women who are media professionals in the Hollywood / Southern California area. In addition, ongoing one-on-one evangelism, mentoring, and spiritual conversations are undertaken through outreach events. In 2016, there were several regular Bible studies throughout the area, plus frequent executive-level women's events, and a Christmas open house for media professionals. Fellowship gatherings are held periodically to encourage and uplift Christians who work in the various area media structures.
